The recipients will be notified 7 calendar days after the application deadline (January 20). During the NCTWS Annual Meeting, a formal announcement will be made to the membership of the winning recipients during the annual member's meeting on Thursday morning. While not required, the NCTWS will request a picture taken of all recipients to include in the NCTWS newsletter, The Wildlifer.

Recipients will only be awarded funding for actual travel expenses (up to \$200). To collect the grant, the recipients will need to send the NCTWS Treasurer a request for reimbursement, including receipts for all expenses, within 14 calendar days after the annual meeting. Mileage on personal vehicles will be at the federal/state rate (\$0.54 per mile).
